MANDATORY EVACUATION ORDERS

- THE MANDATORY EVACUATION ORDER IS **EXPANDED** TO INCLUDE: ALL RESIDENCES TO THE EAST OF HWY 154 FROM PAINTED CAVE TO EAST CAMINO CIELO (NORTHERN BOUNDARY) SOUTH TO FOOTHILL ROAD (SOUTHERN BOUNDARY) EAST TO MORADA LANE/ONTARE ROAD.
- THE OVERALL MANDATORY EVACUATION ORDER AREAS NOW INCLUDE: HWY 154 (WESTERN BOUNDARY) FROM PAINTED CAVE TO EAST CAMINO CIELO (NORTHERN BOUNDARY) SOUTH TO FOOTHILL ROAD (SOUTHERN BOUNDARY) EAST TO SAN ROQUE.
